

UPDATED EXPIRATION DATE EXTENSION NOTICE FOR PEMGARDA®



Audience

Healthcare facilities and healthcare professionals including physicians, pharmacists, nurse practitioners, nurses, and public health officials.

Key messages for healthcare professionals

- On July 1, 2026, the FDA granted an extension of the shelf-life from 36 months to 48 months for all packaged lots of PEMGARDA injection.
- Invivyd, Inc. is now updating the expiry dates for all packaged lots of PEMGARDA to ensure that appropriate action is taken. Please refer to the table below for the updated expiry dates.
- The approved storage conditions remain unchanged.
- Healthcare professionals are advised that:
 - PEMGARDA can still be used after the printed expiration date, which can be found on both the carton and the individual vials.
 - The expiration date of PEMGARDA must be verified against the below table prior to dispensing. Check the expiration date ("EXP") and lot number ("LOT") on the label and refer to the below table for detailed date extensions.

What is the issue?

On July 1, 2026, the FDA granted an extension of the shelf-life from 36 months to 48 months for all packaged lots of PEMGARDA. The FDA had previously granted extensions to these same lots to 36 months. FDA allows updates to expiration dates for products authorized under emergency use without the need to re-label. Accordingly, Invivyd is now extending the expiration dates of all packaged lots of PEMGARDA and ensuring appropriate action is taken through this communication. The FDA has approved the extension of the expiration dates as summarized in the table below.

If you have a PEMGARDA carton or vial labeled with an expiration date and corresponding Lot Number listed in the table below, please see the right column to find the updated extended expiration date.

*Note that the labeled expiration date is valid until the last day of the month.

- **PEMGARDA is authorized only for the duration of the declaration that circumstances exist justifying the authorization of the emergency use of PEMGARDA under Section 564(b)(1) of the FD&C Act, 21 U.S.C. § 360bbb 3(b)(1), unless the authorization is terminated or revoked sooner.**
